# INSTALLATION SPECIFICATIONS: (Double Layer: Slopes of 2:12 to 4:12) DuPont<sup>TM</sup> Roof Protector<sup>TM</sup> Roof Underlayment

- 1. **DuPont<sup>TM</sup> Roof Protector<sup>TM</sup>** Roof Underlayments shall be installed in strict compliance with applicable Building Code.
- **2. DuPont<sup>™</sup> Roof Protector<sup>™</sup>** Roof Underlayments shall be installed in a double layer beginning with a 26" undercourse strip parallel to the eave edge, and then cover with the full width sheet. Overlap successive sheets by 26".
- 3. **DuPont<sup>TM</sup> Roof Protector<sup>TM</sup>** Roof Underlayments shall be fastened with a minimum 4" side lap and a 6" end lap mechanically fastened to deck with approved nails and tin caps 6" o.c. at the laps and shall be attached to a nailable deck in a grid pattern of 12 inches (305 mm) between the overlaps, with 6-inch (152 mm) spacing at the overlaps..
- **4. DuPont**<sup>TM</sup> **Roof Protector**<sup>TM</sup> Roof Underlayments may be used with Asphaltic shingles, Wood shakes and shingles, Non-structural metal roofing, and quarry slate.
- **5.** For fire classification of specific roof assemblies using **DuPont<sup>TM</sup> Roof Protector<sup>TM</sup>** Roof Underlayments refer to a current Approved Roofing Materials Directory for fire ratings of this product.

- 1. **DuPont<sup>TM</sup> Roof Protector<sup>TM</sup>** Roof Underlayments shall be installed in strict compliance with applicable Building Code.
- 2. **DuPont<sup>TM</sup> Roof Protector<sup>TM</sup>** Roof Underlayments shall be installed with a minimum 4-inch horizontal lap and 6-inch vertical laps in a shingle layer fashion. Vertical laps in a succeeding course shall be staggered from those in preceding course by minimum 6-feet.
- **3. DuPont<sup>TM</sup> Roof Protector<sup>TM</sup>** Roof. Underlayment shall be attached to a nailable deck in a grid pattern of 12 inches (305 mm) between the overlaps, with 6-inch (152 mm) spacing at the overlaps.

#### **LIMITATIONS:**

- 1. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire ratings of this product.
- 2. This acceptance is for prepared roofing applications. Minimum deck requirements shall be in compliance with applicable building code.
- **3. DuPont<sup>™</sup> Roof Protector<sup>™</sup>** Roof Underlayments shall be applied to a smooth, clean and dry surface with deck free of irregularities. All nails in the deck shall be carefully checked for protruding heads. Re-fasten any loose decking panels. Sweep the deck thoroughly to remove any dust and debris prior to application.
- **4. DuPont<sup>TM</sup> Roof Protector<sup>TM</sup>** Roof Underlayments shall not be hot mopped, refer to manufacturer's published literature for product compatibility.
- **DuPont<sup>TM</sup> Roof Protector<sup>TM</sup>** Roof Underlayments shall not be left exposed as a temporary roof for longer than 30 days of application.
- **6. DuPont<sup>TM</sup> Roof Protector<sup>TM</sup>** Roof Underlayments are components used in roof system assemblies. Roof system assemblies are approved under a specific Notice of Acceptance.
