Deck Attachment: In accordance with applicable Building Code, but in no case shall it be less than 8d annular

ring shank nails spaced 6" o.c. In reroofing, where the deck is less than ¹⁹/₃₂" thick (Minimum

¹⁵/₃₂") The above attachment method must be in addition to existing attachment.

Underlayment: Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4" side-

lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 12 gauge 1 1/4" annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12"

o.c. in the field of the roll or any approved underlayment having a current NOA.

Additionally, install a layer of a MFM Building Products Ultra HT Wind & Water Seal self-adhered underlayment, or Miami Dade Approved self-adhered underlayment that meets

ASTM D 1970, on top of the ASTM D 226 Type II underlayment.

Fire Barrier: Any approved fire barrier having a current NOA. Refer to a current fire directory listing for

fire ratings of this roofing system assembly as well as the location of the fire barrier within

the assembly. See Limitation # 1.

Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133 and

with the current published installation instructions and details in Metal Alliance Inc's

Installation Manual.

Metal Panels and

Accessories:

Install the "3/4" Corrugated Steel Panel" including flashing penetrations, valleys, end laps and accessories in compliance with Metal Alliance Inc's current, published installation instructions and in compliance with the minimum requirements detailed in Roofing

Application Standard RAS 133.

3/4" Corrugated Steel Panel shall be secured with #9 HWH fasteners with, self-sealing washers, of sufficient length to penetrate through the deck at a minimum of ½". Fasteners shall be placed at the center of every other peak at a spacing listed below in **Table A**.

Snap fit the female end of the adjacent panel over the clip/panel male assembly.

- 3. Panel shall be roll formed in continuous lengths from eave to ridge. Maximum lengths shall be described in the Roofing Application Standard RAS 133.
- All panels shall be permanently labeled with the manufacturer's name and/or logo, city and state of manufacturing 4. facility, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.



All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and 5. Rule 61G20-3 of the Florida Administrative Code.








3/4" Corrugated Panel, Narrow Version







3/4" Corrugated Panel, Wide Version



Fastening pattern, horizontal






PANEL SIDELAP
