Panels shall be installed along the rib with SNAP-CLAD Clips secured with #14 pan head selftapping screws (2 per clip for individual clip; 8 per clip for continuous clip); the screws shall be of sufficient length to penetrate through the deck a minimum of ½". The female rib of panel is snapped over the male rib of panel. Panel clips shall be spaced a maximum distance listed

below in Table A.


- **5.** All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule **61G20-3** of the Florida Administrative Code.
