**Deck Attachment:** 

In accordance with applicable building code, but in no case shall it be less than #8d annular ring shank nails spaced 6" o.c. In reroofing, where the deck is less than <sup>19</sup>/<sub>32</sub>" thick (Minimum <sup>15</sup>/<sub>32</sub>") the above attachment method must be in addition to existing attachment.

**Underlayment:** 

Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4" side-lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 12 gauge 1 1/4" annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll. Or, any approved underlayment having a current NOA.

Fire Barrier:

Any approved fire barrier having a current NOA. Refer to a current fire directory listing for fire ratings of this roofing system assembly as well as the location of the fire barrier within

the assembly. See Limitation #1.

Valleys:

Valley construction shall be in compliance with Roofing Application Standard RAS 118 and with Brava Technologies LLC's current published installation instructions.

**Starter:** 

Install starter over the 1" thick cant strip and fasten with two (2) #10 screws in the designated nail holes.

**Tile Installation** (Field Condition): Install the "Brava Old World Spanish A4 Composite Tile" and accessories in compliance with the current published installation instructions and details in Brava Technologies LLC's Installation Manual. Flashings, penetrations, valley construction and other details shall be constructed in compliance with Roofing Application Standard RAS 133.

Each panel is installed with (2) two 1/8" diameter corrosion resistant roofing nails of sufficient length to penetrate through the sheathing a minimum 3/16" of an inch, through the designated nail holes. (See Detail A)

The adjoining tile is laid next to the existing tile overlapping the edge. The next row is laid with a 13" exposure. (See Detail B)

Tile Installation (Perimeter and Corner Condition): Install the "Old World Spanish A4 Composite Tile" and accessories in compliance with the current published installation instructions and details in Brava IP LLC's Installation Manual. Flashings, penetrations, valley construction and other details shall be constructed in compliance with Roofing Application Standard RAS 133.

Each panel is installed with (2) two corrosion resistant #10 screws of sufficient length to penetrate through the sheathing a minimum 3/16" of an inch, through the designated nail holes. (See Detail A)

The adjoining tile is laid next to the existing tile overlapping the edge. The next row is laid with a 13" exposure. (See Detail B)

4. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.




# **Brava Old World Spanish A4 Composite Tile**
