<b>Deck Type 1:</b>	Wood, Non-insulated
<b>Deck Description:</b>	<sup>19</sup> / <sub>32</sub> " or greater plywood or wood plank
<b>System E(1):</b>	Anchor sheet mechanically fastened to deck, membrane adhered
<b>Anchor Sheet:</b>	One or more plies of ASTM D 226 Type II or ASTM D 2626 with a minimum 4" side lap and a 6" end lap mechanically fastened to deck with approved nails and tin caps 6" o.c. at the laps and two staggered rows 12" o.c. the field of the roll.
<b>Membrane:</b>	One or more plies of Alco Shield #275 Ice and Water Protector self-adhering membrane adhered to the anchor sheet with a minimum 3" side lap and 6" end lap. Place the first course of membrane parallel to the eave, rolling the membrane to obtain maximum contact. Remove the release membrane as the membrane is applied. Vertical strapping of the membrane is acceptable. If membrane is strapped, then anchor sheet must also be strapped.
<b>Surfacing:</b>	Shall be acceptable for use in approved asphaltic shingles, wood shakes, & shingles, quarry slate, and metal roof applications. Must Comply with applicable Roofing Application Standards and Building Codes

## LABELING:

All membranes or packaging shall bear the imprint or identifiable marking of the manufacturer's name or logo and the following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.

## **LIMITATIONS:**

1. Fire classification is not part of this acceptance.
2. Alco Shield #275 Ice and Water Protector shall be acceptable for use in asphaltic shingles, wood shakes, & shingles, quarry slate, and metal roof applications.
3. This acceptance is for prepared roofing applications. Minimum deck requirements shall be in compliance with applicable building code. Alco Products LLC's Alco Shield #275 Ice and Water Protector underlayment roofing systems shall be installed in strict compliance with applicable Building Code.
4. Alco Shield #275 Ice and Water Protector underlayment roofing systems membranes shall be applied to a smooth, clean and dry surface with deck free of irregularities.
5. Alco Shield #275 Ice and Water Protector underlayment roofing systems membranes shall not be applied over an existing roof membrane as a recover system but may be applied over an approved roofing Base/Anchor sheet underlayment.
6. Alco Shield #275 Ice and Water Protector or shall not be left exposed as a temporary roof for longer than 30 days of application.
7. Alco Products LLC underlayment products may be used with any approved roof covering Notice of Acceptance listing Alco Products LLC. underlayment products as a component part of an assembly in the Notice of Acceptance. If Alco Products LLC underlayment products are not listed, a request may be made to the Authority Having Jurisdiction (AHJ) or the Miami-Dade County Product Control Department for approval provided that appropriate documentation is provided to detail compatibility of the products, wind uplift resistance, and fire testing results.
8. All nails in the deck shall be carefully checked for protruding heads. Re-fasten any loose decking panels. Sweep the deck thoroughly to remove any dust and debris prior to application.
9. When applying the membrane in the valley, start at the low point and work to the high point, rolling the membrane from the center outward in both directions.
10. Roll or broom the entire membrane surface so as to have 100% contact with the surface, giving special attention to overlap areas.
11. Flash vent pipes, stacks, chimneys and penetrations in compliance with Roof Assembly current Product Control Notice of Acceptance and applicable Building Code.
12. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
