Anchor/Base Sheet: One or more plies of PolyAnchor secured with 12 ga. nails and tin caps spaced 6-in. o.c. at

the 3-in. side laps and 12-in. o.c. at three equally spaced, staggered center rows.

Membrane: Shingle-On-A-Roll, self-adhered and secured with 12 ga. nails and tin caps spaced 12-in. o.c.

in one row centered in the half sheet lap.

Deck Type 1: Wood, non-insulated

Deck Description: Min. 19/32" plywood or wood plank **System Type E(2):** Membrane mechanically fastened to deck.

Anchor/Base Sheet: One or more plies of PolyAnchor secured with 12 ga. nails and tin caps spaced 6-in. o.c. at

the 3-in. side laps and 6-in. o.c. at three equally spaced, staggered center rows.

Membrane: Shingle-On-A-Roll, self-adhered and secured with 12 ga. nails and tin caps spaced 12-in. o.c.

in one row centered in the half sheet lap.

INSTALLATION

1.Shingles-on-a-Roll shall be installed as outlined above in Approved Assemblies.

2.Flashing shall be in accordance with Roofing Applications Standard RAS-115.

3.The manufacturer shall provide clearly written application instruction.

LABELING:

Shingles shall bear the imprint or identifiable marking of the manufacturer's name or logo, city and state of manufacturing facility, and following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.






SHINGLE-ON-A-ROLL MEMBRANE
