1. **Deck Type:** Primed or unprimed structural concrete.

Insulation

Base layer: One or more layers, min. 1.5" thick ACFoam II, E"NRG"Y-2, Iso+ GL or Insul-Tek, adhered to substrate with manufacturer supplied hose and wand or multi-bead applicator in a continuous ³/₄ to 1 inch minimum wide beads of adhesive spaced 12" on center. Insulation boards are immediately placed over adhesive beads and walked in.

Top Layer: Min. ½" thick GAFTEMP Recover Board insulation adhered to base layer with manufacturer supplied hose and wad or multi-bead applicator in a continuous ¾ to 1 inch minimum wide beads of adhesive spaced 12" on center, beads shall be perpendicular to bottom layer of insulations.

Membrane: Min. 3 ply type IV glass felt BUR or any approved roof covering system with current NOA as detailed in this approval.

<u>Note:</u> Fire Rating and maximum design pressure ratings shall be as defined in the Roof Assembly Notice of Acceptance.

2. **Deck Type:** Primed or unprimed structural concrete.

Insulation

Base layer: One or more layers, min. 1.5" thick ACFoam II, E"NRG"Y-2, Iso+ GL, adhered to substrate with manufacturer supplied hose and wand or multi-bead applicator in a continuous ¾ to 1 inch minimum wide beads of adhesive spaced 12" on center. Insulation boards are immediately placed over adhesive beads and walked in.

<u>Membrane:</u> Fibertite, Sure-Seal Reinforced Standard, Sure-Seal Reinforced FR, Stevens Hypalon (CSM), or Stevens EP (TPO) with current Notice of Acceptance, fully adhered to insulation with the solvent based membrane adhesive as listed in the roof assembly Notice of Acceptance.

<u>Note:</u> Fire Rating and maximum design pressure ratings shall be as defined in the Roof Assembly Notice of Acceptance.

Insulation

Base laver: One or more layers, min. 1.5" thick ACFoam II, E"NRG"Y-2, Iso+ GL or Insul-Tek, adhered to substrate with manufacturer supplied hose and wand or multi-bead applicator in a continuous ³/₄ to 1 inch minimum wide beads of adhesive spaced 12" on center. Insulation boards are immediately placed over adhesive beads and walked in.

Min. ½" thick approved high-density wood fiber board roof insulation adhered to base layer with manufacturer supplied hose and wand or multi-bead applicator in a continuous ¾ to 1 inch minimum wide beads of adhesive spaced 12" on center, beads shall be perpendicular to bottom layer of insulations.

Fibertite, Sure-Seal Reinforced Standard, Sure-Seal Reinforced FR fully Membrane: adhered to wood fiber board insulation with the solvent based membrane adhesive as listed in the roof assembly Notice of Acceptance or min 3 ply Type IV glass felt BUR with current Notice of Acceptance.

Note: Fire Rating and maximum design pressure ratings shall be as defined in the Roof Assembly Notice of Acceptance.

4. Deck Type: Primed or unprimed structural concrete.

Insulation

One or more layers, min. 1.5" thick ACFoam II, E"NRG"Y-2, Iso+ GL, Insul-Base layer: Tek, adhered to substrate with manufacturer supplied hose and wand or multi-bead applicator in a continuous ³/₄ to 1 inch minimum wide beads of adhesive spaced 12" on center. Insulation boards are immediately placed over adhesive beads and walked in.

Top Laver: Min. 1/4" thick Georgia Pacific Dens-Deck® (with current NOA) adhered to base layer with manufacture supplied hose and wand or multi-bead applicator in a continuous 3/4 to 1 inch minimum wide beads of adhesive spaced 12" on center, beads shall be perpendicular to bottom layer of insulations.

Membrane:

- One or Two plies Brai SP4 or one ply of Brai SP4 and one ply of Brai GBSP4 a) with current Notice of Acceptance, torch applied to Georgia Pacific Dens-Deck® gypsum cover board. Hi-Tuff or Hi-Tuff EP roof cover fully adhered to gypsum cover board.
- Fibertite, Sure-Seal Reinforced Standard, Sure-Seal Reinforced FR, Stevens b) Hypalon (CSM), Stevens EP (TPO) with current Notice of Acceptance, fully adhered to Georgia Pacific Dens-Deck® gypsum cover board with the solvent based membrane adhesive as listed in the roof assembly Notice of Acceptance

5. 22 gage metal deck. **Deck Type:**

Insulation

Base layer: Min. 1.5" thick ACFoam II, Pyrox, E"NRG"Y-2, Iso 95+GL or other approved roof insulations, secured to metal deck with 8 Insul-Fixx P plates and Insulfix fasteners per board (rate of 1 fasteners per ft² of insulation board). One or more layers of above listed roof insulations adhered to mechanically attached base layer with manufacturer supplied hose and wand or multi-bead applicator in a continuous ³/₄ to 1 inch minimum wide bead of adhesive spaced 12" o. c. Insulation boards are immediately placed over adhesive beads and walked in.

Min. 1/2" thick approved high-density wood fiber board or minimum 1/4" Dens Deck roof insulation adhered to base layer with manufacture supplied hose and wand or multibead applicator in a continuous ³/₄ to 1 inch minimum wide beads of adhesive spaced 12" on center, beads shall be perpendicular to bottom layer of insulations.

Unreinforced Sure-Seal EPDM fully adhered to wood fiber board insulation Membrane: with Sure-Seal 90-8-30A Bonding Adhesive.

Fire Rating and maximum design pressure ratings shall be as defined in the Roof Assembly Notice of Acceptance.

- Insta Stik™ Quik Set Insulation Adhesive is a component used in approved roof assemblies. Roof assemblies 2. are approved under specific roof assembly Notice of Acceptances.
- 3. Insta StikTM Quik Set Insulation Adhesive may be used with any approved roof assembly listing Insta StikTM Quik Set Insulation Adhesive as a component part of an assembly in the approval.
- Insta Stik™ Quik Set Insulation Adhesive shall mark each packing container or label with manufacturer's name, 4. address, shelf life of product, and with the Miami-Dade logo or the words "Miami-Dade Approved."
- 5. Fire Rating and maximum design pressure ratings shall be as defined in the Roof System's Notice of Acceptance.
- 6. In steel deck construction base layer of insulation shall be mechanically fastened to deck. Optional top layer of insulation may be adhered with Insta StikTM Quik Set Insulation Adhesive as described in this approval.
- 7. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
