	• Aluminum Roofs: Apply base coat at a minimum rate of 1.5 gal/100 ft <sup>2</sup> and topcoat at a rate of 1.5 gal/100 ft <sup>2</sup> . Minimum 21 dry mils.		
	• <b>Kynar Roofs:</b> Apply Primer Base Coat at a minimum rate of 3 wet mils @ 250 sq. ft./gal and middle coat at a minimum rate of 1.5 gal/100 ft <sup>2</sup> and topcoat at a rate of 1.5 gal/100 ft <sup>2</sup> . Minimum 21 dry mils.		
Container Sizes:	1, 5gallon pails and 50 gallon drums. Note cautions on container label.		
Systems Approvals:	Methods of application and quantities shall comply with the specific Roof Assembly System's Product Control Notice of Acceptance where it exceeds standards of this NOA.

The Blair products listed herein are components of roof assemblies and are approved for use with roof assemblies that list any of the products listed herein as part of their roof assemblies Notice of Acceptance. If a product is not listed as part of roof assemblies Notice of Acceptance, a request may be made to the local building official or the Miami Dade County Product Control Section for approval provided that appropriate documentation is provided.
- 4. Change in materials, use, or manufacture of any of the products listed herein shall be cause for termination of this Notice of Acceptance.
- 5. Blair products listed herein shall be applied in accordance with manufacturer's published application instructions.
- 6. Blair products listed herein shall have an unannounced follow-up quality control program from an approved listing agency. Follow up test results shall be made available to the Miami Dade Product Control upon request.
- 7. The use of a reinforcing fabric in a maintenance coating is only to enhance the coating's ability to deliver efficient and long term performance through the protection of the underlying roof system and in this particular use does not become a roof system itself.
- 8. Blair products listed herein shall only be used as a roof or exterior maintenance coating over substrates specified herein.
- **9**. Curing and Drying time is 2-4 hours; (typical in optimal weather or 4-6 hours in non-optimal weather), before recoating
- **10.** Blair products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
- 11. All approved products listed herein shall be labeled in compliance with TAS 121 and shall bear the imprint or identifiable marking of the manufacturer's name or logo, city and state of manufacturing facility, and the following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.
