APPROVED APPLICATIONS:

Trade name: TopShield® TSP60-PRO Roof Vent

System Type A: Mechanical attachment of attic vent over and underneath composition shingles.

Cutout: Center the vent opening between rafters and roughly 24" (36" Max.) down from the ridge line

to keep the top of the roof vent below the ridge line. Mark this position.

Using the marked position as the center point, scribe a nominal 9" x 9" square pattern. Cut a nominal 9" square hole through the shingles and sheathing following the hole pattern.

nonlinar / square note unough the shingles and sheathing following the note pattern.

Sealant should be placed on the underside of the base. Sealant should be a 1/2" bead spaced 1"

around the throat of the vent.

With the embossed arrow pointed up toward the ridge, carefully slide the vent into place centering the throat of the vent over the vent opening. The base flange should be positioned over the opening with the top half (upslope) of the flange positioned beneath shingles and the bottom half (downslope) of the flange positioned on top of the shingles.

Fasten the base to the roof decking with 12ga, 1-1/4" galvanized ring shank nails. Nails should be located as follows: four (4) located a nominal 1/2" from bottom flange edge at pre-marked locations; two (2) located a nominal 1/2" from top flange edge at premarked locations; and one (1) located along each side edge a nominal 1/2" from the edge and centered along the length. A total of eight (8) fasteners are to be utilized.

Finish installation by sealing any exposed nail heads or loose shingles with approved roofing

cement.


