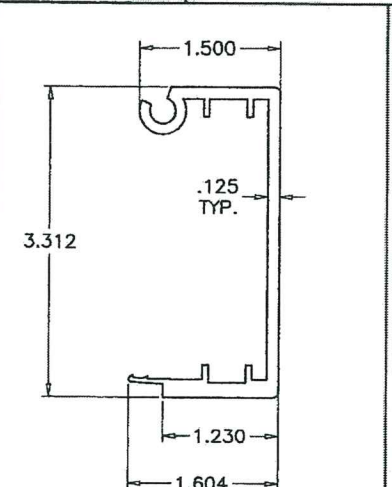


⑦ EXTERIOR GLAZING GASKET

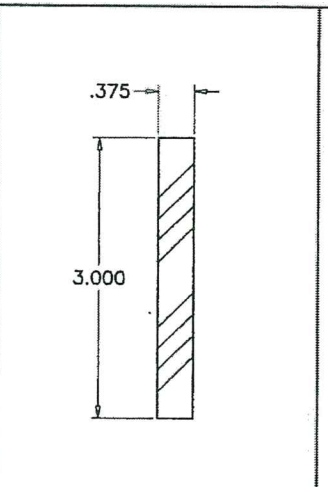
⑧ INTERIOR GLAZING GASKET

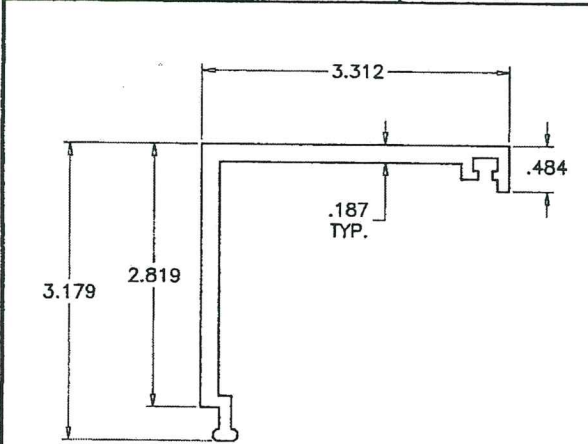
