Panels shall be secured with corrosion resistant #12 of sufficient length to penetrate through the sheathing a minimum of  $\frac{3}{16}$ " with plastic washers. The screw/washer shall be placed at every available slot in the shingle. (See Detail A) The panels in the next row shall be installed by attaching the bottom of the shingle to the top of the shingle of the

row below. The panel is then secured as described above.

The "Wakefield Bridge Steel Shingle" shall be installed from left to right starting with a full panel on the first row, 2/3 and 1/3 of a panel on the second and third row. Repeat the

steps for the remainder of the roof section.


#### LIMITATIONS

All panels shall be permanently labeled with the manufacturer's name and/or logo, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.
