valley construction and other details shall be constructed in compliance with Roofing Application Standard RAS 133. Male leg of snap seam shall be caulked with a minimum 1/8"

bead of elastomeric construction sealant prior to installation of female leg of panel.

Panels shall be installed with galvanize steel clips (3½" long x 2½" wide x 1¾" tall), attached to substrate with (2) two corrosion resistant #10-13 self-tapping pancake screws of sufficient length to penetrate through the sheathing a minimum of $\frac{3}{16}$ ". Clip fastening shall start 8"

from panel end and shall be at maximum spacing as described below in **Table A**.




