2. Shall not be installed on roof mean heights in excess of 33 ft.
3. This acceptance is for wood deck applications. Minimum deck requirements shall be in compliance with applicable Building Code
4. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.

INSTALLATION

1. McVantage of Guyana, Inc's Sandura Wooden Shingles and its components shall be installed in strict compliance with Roofing Application Standard (RAS) 130 with the following exception:
 - a. One 36" wide layer of Miami-Dade Approved self-adhered underlayment shall be applied over the ASTM D 226 anchor sheet on any valley, extending 18" to either side. Valley metal shall be applied over the self-adhered underlayment as per Roofing Application Standard (RAS) 130.
