System:	Coastal 5V, 26ga. Steel Panel
Deck Type:	Wood, Non-insulated
Deck Description:	New Construction $\frac{19}{32}$ " or greater plywood or wood plank.
Slope Range:	2": 12" or greater
Maximum Uplift Pressure:	See Table A below
Deck Attachment:	In accordance with applicable Building Code, but in no case shall it be less than 8d annular ring shank nails spaced 6" o.c. In reroofing, where the deck is less than $^{19}/_{32}$ " thick (Minimum $^{15}/_{32}$ ") The above attachment method must be in addition to existing attachment.
Underlayment:	Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4' side-lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 12 gauge 1 ¹ / ₄ " annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll or any approved underlayment having a current NOA.
Fire Barrier Board:	Any approved fire barrier having a current NOA. Refer to a current fire directory listing for fire ratings of this roofing system assembly as well as the location of the fire barrier within the assembly. See Limitation # 1.
Valleys:	Valley construction shall be in compliance with Roofing Application Standard RAS 133 and with the current published installation instructions and details in Coastal Metal Roofing Sales LLC.'s Installation Manual.
Metal Panels and Accessories:	Install the "Coastal 5V 26 gauge Steel Metal Panels" including flashing penetrations valleys, end laps and accessories in compliance "Coastal Metal Roofing Sales LLC.'s' current, published installation instructions and in compliance with the minimum requirements detailed in Roofing Application Standard RAS 133.
	Panels shall be secured along the top of the V's (See Detail A herein) with approved corrosion resistant #10 x 1-1/2" HiLo HWH fasteners with weather seal washer, or sufficient length to penetrate through the sheathing a minimum of $^{3}/_{16}$. The fasteners are to be placed at a spacing listed in Table A below starting 3" from panel end.

- 2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners).
- **3.** Panels may be roll formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, city and state, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
