Install the "V MAX Steel Panel" including flashing penetrations, valleys, end laps and accessories in compliance "Extreme Metal Fabricators, LLC.'s" current, published Accessories: installation instructions and in compliance with the minimum requirements detailed in

Panels shall be secured along the top of the "V's" as shown in the detail drawings herein with corrosion resistant #10 fasteners of sufficient length to penetrate through the sheathing a minimum of  $^{3}/_{16}$ ". The fasteners spacing along the "V's" shall be as listed in **Table A** 

below.

- 2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e., field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e., perimeters, extended corners and corners).
- **3.** Panel shall be roll formed in continuous lengths from eave to ridge. Maximum lengths shall be described in the Roofing Application Standard RAS 133.
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, city and state of manufacturing facility, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




