

APPLICATION NOTES

- 1) SHEATHING FABRIC IS EMBEDDED IN SENERSHIELD-R AT SHEATHING JOINTS. SHEATHING FASTENERS ARE SPOTTED WITH SENERSHIELD-R.
- 2) APPLY SENERSHIELD-R TO SHEATHING SURFACE UNIFORMLY AT 10 MILS WET.
- 3) APPLY SENERGY DRAINAGE MAT OVER SENERSHIELD-R WITH EDGES BUTTED, ATTACH TO SHEATHING WITH SUFFICIENT STAPLES TO STAY IN PLACE UNTIL INSULATION BOARD APPLICATION.
- 4) NEOPOR RIGID INSULATION BOARD HAS A NOMINAL DENSITY OF 1.35 PCF (ASTM C578 TYPE II) AND SHALL BE APPLIED HORIZONTALLY IN A RUNNING BOND PATTERN STAGGERING VERTICAL JOINTS AND CORNERS. 2 FASTENERS PER BOARD ARE USED TO HOLD IT IN PLACE UNTIL LATH INSTALLATION.
- 5) PERMALATH 1000 IS ATTACHED INTO THE FRAMING AT 6" OC WITH #8 X 2 5/8" SELF DRILLING SCREWS WITH WIND LOCK LATH PLATES (1 1/4" DIAMETER).

- 6) ALL STEEL STUDS SHALL BE STRUCTURAL WITH 1 5/8" MIN FLANGE WIDTH AND HAVE A MINIMUM YIELD STRENGTH OF 33000 PSI








