In addition, (a) each Certified Extrusion shall be labeled every 4 ft or less on the underside with the Extruder Code and "MDCA" or (b) each finished product assembly shall be labeled with a permanent label and/or stamp with the Extruder Code and "MDCA".

RENEWAL of this NOA shall be considered after a renewal application has been filed and there has been no change in the applicable building code negatively affecting the performance of this product.

TERMINATION of this NOA will occur after the expiration date or if there has been a revision or change in the materials, use, and/or manufacture of the product or process. Misuse of this NOA as an endorsement of any product, for sales, advertising or any other purposes shall automatically terminate this NOA.
