Valley construction shall be in compliance with Roofing Application Standard RAS 133 and Valleys:

Association's Roofing Installation Manual.

**Metal Panels and Accessories:** 

Install the "Tite-Loc Plus 24 ga. Steel Panel" panels including flashing penetrations, valleys, end laps and accessories in compliance PAC Contractors Association's current, published installation instructions and in compliance with the minimum requirements detailed in

Roofing Application Standard RAS 133.

Tite-Loc panels shall be secured with Tite-Loc Plus clips at a spacing listed below in Table A. Clips are to be fastened with a minimum of two #10 x 1-1/2" long pancake head screws

of sufficient length to penetrate through the deck at a minimum of  $^{3}/_{16}$ ".

Place the female end of the adjacent panel over the clip/panel male assembly and seam 180° degree. See Detail A herein. Factory or field applied sealant in the seam is optional.


#### System Limitations














**CLIP OPTION 1**
