current, published installation instructions and in compliance with the minimum requirements

detailed in Roofing Application Standard RAS 133.

Panels shall be installed along the rib with SNAP CLAD Clips secured with #14 pan head screws (2 per clip for individual clip; 8 per clip for continuous clip); the screws shall be of sufficient length to penetrate through the deck a minimum of ½". The female rib of panel is snapped over the male rib of panel. Panel clips shall be spaced a maximum distance listed

below in **Table A**.

- 3. Panels may be roll formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133.
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, city, state, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




