### APPROVED APPLICATIONS

**Tradename:** Hip Ridge Vent<sup>TM</sup>

**System Type**: Mechanical attachment of static vent over asphalt shingle roof systems only.

Minimum Slope: 3:12 Maximum Slope: 12:12

Cutout: Cut a minimum 6" slot along the apex of the roof hip by cutting 3" on each side of the hip. The

slot shall terminate approximately 6" from the top and 12" from the bottom of the hip.

**Installation:** Place Hip Ridge Vent<sup>TM</sup> centered over the void at one end of the hip ridge. There should be 6-

1/2" of the vent on either side of the hip/ridge. Secure the vent with 2-1/2" galvanized ring shank

nails through pre-formed nail bosses along the vent.

**Ridge Shingle:** Nail cap shingles in place using roofing nails long enough to penetrate through the roof sheathing

a minimum of  $^{3}/_{16}$  of an inch.

**Net Free Area:** Refer to manufacturers published literature.

### **LIMITATIONS:**

1. Refer to applicable Building Codes for required ventilation.


- 2. This acceptance is for installations over asphalt shingle roof systems only.
- 3. Hip Ridge Vent<sup>TM</sup> shall not be installed on roof mean heights greater than 33 feet.
- 4. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
- 5. All approved products listed herein shall be labeled and shall bear the imprint or identifiable marking of the manufacturer's name or logo and following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.





