Deck Description:	New Construction $^{19}/_{32}$ " or greater plywood or wood plank, or for re-roofing 15/32" or greater plywood.

Metal Panels and Accessories:	Install the "Snap-Clad 24 ga. x 12"-18" Wide Steel Panel" panels including flashing penetrations, valleys, end laps and accessories in compliance PAC Contractors Association's current, published installation instructions and in compliance with the minimum requirements detailed in Roofing Application Standard RAS 133.				
	Panels shall be installed along the rib with SNAP CLAD Clips secured with #10 fasteners (2 per clip for individual clip; 8 per clip for continuous clip); the screws shall be of sufficient length to penetrate through the sheathing a minimum of $3/16$ ". The female rib of panel is snapped over the male rib of panel. Panel clips shall be spaced a maximum distance listed below in <b>Table A</b> .


- 1. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire ratings of this product.

- **3.** Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133.
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, city, state, and the following statement: "Miami-Dade County Product Control Approved" **or** with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.
