Metal Panels and Accessories:

Install the "Tite-Loc Plus 0.032" Aluminum Panel "panels including flashing penetrations, valleys, end laps and accessories in compliance PAC Contractors Association's current, published installation instructions and in compliance with the minimum requirements

detailed in Roofing Application Standard RAS 133.

Tite-Loc panels shall be secured with Tite-Loc Plus clips at a spacing listed below in Table A. Clips are to be fastened with a minimum of two #10 x 1-1/2" long pancake head screws

of sufficient length to penetrate through the deck at a minimum of $^{3}/_{16}$ ".

Place the female end of the adjacent panel over the clip/panel male assembly and seam 180° degree. See detail herein. Factory or field applied sealant in the seam is optional.


SYSTEM LIMITATIONS

- **3.** Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133.

All panels shall be permanently labeled with the manufacturer's name and/or logo, city, state, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.











ISOMETRIC VIEW




ISOMETRIC VIEW
