Approved Roof System Applications:

- Aluminum and Steel Metal Roofs: Prime any corroded areas with RC 2000, ALDOCOAT 900 Rubber Roof Coating or TRUCO 7140NF Rubber Roof Coating at an application rate of 1.0 gal/100 ft². Seams shall be coated with RC 2200 Rubber Seam Compound, ALDOSEAL 920 Rubber Seam Compound or TRUCO 7141NF Rubber Seam Compound as needed. Allow adequate dry time between coats. A minimum of one finish coat of RC 2000 Rubber Roof Coating, ALDOCOAT 900 Rubber Roof Coating or TRUCO 7140NF Rubber Roof Coating applied by brush, roller or spray at an application rate of 1.0 gal/100 ft².
- Granule Surface SBS and Smooth Surface APP Modified Bitumen: Prime with a coat of DF 1000 Rubber Deck Filler, ALDOBASE 910 Rubber Deck Filler or TRUCO 7143NF Rubber Deck Filler at an application rate of 1.5 gal/ 100 ft². Apply a minimum of one finish coat of RC 2000 Rubber Roof Coating, ALDOCOAT 900 Rubber Roof Coating or TRUCO 7140NF Rubber Roof Coating applied by brush, roller or spray at a rate of 1.0 gal/ 100 ft².
- Smooth Surface BUR: Prime with a coat of DF 1000 Rubber Deck Filler, ALDOBASE 910 Rubber Deck Filler or TRUCO 7143NF Rubber Deck Filler at an application rate of 1.5 gal/100 ft². Apply a minimum of one finish coat of RC 2000 Rubber Roof Coating, ALDOCOAT 900 Rubber Roof Coating or TRUCO 7140NF Rubber Roof Coating applied by brush, roller or spray at a rate of 1.0 gal/ 100 ft².
- EPDM & TPO Single Ply: Apply a flash coat of RC 2000 Rubber Roof Coating, ALDOCOAT 900 Rubber Roof Coating or TRUCO 7140NF Rubber Roof Coating applied by brush, roller or spray at an application rate of .75 gal/ 100 ft². Allow surface to dry thoroughly. Seams shall be coated with RC 2200 Rubber Seam Compound, ALDOSEAL 920 Rubber Seam Compound or TRUCO 7141NF Rubber Seam Compound as needed. Apply a minimum of one finish coat of RC 2000 Rubber Roof Coating, ALDOCOAT 900 Rubber Roof Coating or TRUCO 7140NF Rubber Roof Coating by brush, roller or spray at an application rate of 1.0 gal/ 100 ft².
- **Hypalon Single Ply:** Seams shall be coated with RC 2200 Rubber Seam Compound, ALDOSEAL 920 Rubber Seam Compound or TRUCO 7141NF Rubber Seam Compound as needed. Apply a minimum of one finish coat of RC 2000 Rubber Roof Coating, ALDOCOAT 900 Rubber Roof Coating or TRUCO 7140NF Rubber Roof Coating applied by brush, roller or spray at an application rate of 1.25 gal/ 100 ft².
- Spray Polyurethane Foam (SPUF): Apply a minimum of one finish coat of RC 2000 Rubber Roof Coating ALDOCOAT 900 Rubber Roof Coating or TRUCO 7140NF Rubber Roof Coating applied by brush, roller or spray at an application rate of 1.5 gal/ 100 ft².

- 5. All approved products listed herein shall be labeled in compliance with TAS 121 and shall bear the imprint or identifiable marking of the manufacturer's name or logo and following statement: "Miami–Dade County Product Control Approved" or the Miami–Dade County Product Control Seal as shown below.



- 6. Change in materials, use, or manufacture of any of the products listed herein shall be cause for termination of this Notice of Acceptance.
- 7. RC 2000 Rubber Roof Coating System shall be installed in accordance with manufacturer's Product Data Sheet.
- 8. RC 2000 Rubber Roof Coating System shall be used as a roof maintenance coating system in accordance with applicable Building Code. RC 2000 Rubber Roof Coating System is not approved to be used as a repair or recover system.
- 9. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
- 10. If DF 1000 Rubber Deck Filler / ALDOBASE 910 Rubber Deck Filler /TRUCO 7143NF Rubber Deck Filler or RC 2200 Rubber Seam Compound / ALDOSEAL 920 Rubber Seam Compound /TRUCO 7141NF Rubber Seam Compound is installed in areas exposed to weather then it must be top coated with RC 2000 Rubber Roof Coating / ALDOCOAT 900 Rubber Roof Coating /TRUCO 7140NF Rubber Roof Coating as specified by manufacturer's published application instructions.
