	Panels shall be installed along the rib with SNAP CLAD Clips secured with #10 fasteners (2 per clip for individual clip; 8 per clip for continuous clip); the screws shall be of sufficient length to penetrate through the sheathing a minimum of $3/16$ ". The female rib of panel is snapped over the male rib of panel. Panel clips shall be spaced a maximum distance listed below in <b>Table A</b> .


- 1. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire ratings of this product.

- **3.** Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133.
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, city, state, and the following statement: "Miami-Dade County Product Control Approved" **or** with the Miami-Dade County Product Control Seal as seen below.
