


System Limitations

- **3.** Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133.

- 6. Panels may be shop or jobsite roll formed with machine model #('s) <u>061203</u> from PAC Contractors Association.




PROFILE DRAWING




CLIP DETAIL DRAWINGS



ISOMETRIC VIEW




SIDE VIEW


