

- 6. Panels may be shop or jobsite roll formed with machine model #('s) <u>8820305 and 5000522</u> from PAC Contractors Association.




PROFILE DRAWING




CLIP DETAIL DRAWINGS




ISOMETRIC VIEW









FRONT VIEW
