Coverboard: A single layer of 1/2" DensDeck Roof Board was applied over the insulation fastened with

approved #14 pancake head screws long enough to penetrate the steel deck through 3"

diameter insulation plates.

Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133 and

Install the "Tite-Loc Plus 24 ga. Steel Panel" panels including flashing penetrations, valleys, end laps and accessories in compliance PAC Contractors Association's current, published Accessories:

installation instructions and in compliance with the minimum requirements detailed in

Roofing Application Standard RAS 133.

Tite-Loc panels shall be secured with Tite-Loc Plus clips at a spacing listed below in Table A. Clips are to be fastened with a minimum of two #14 x 6" long pan head self-tapping

screws of sufficient length to penetrate through the deck at a minimum of $\frac{1}{2}$ ".

Place the female end of the adjacent panel over the clip/panel male assembly and seam 180°

degree. See Detail A herein. Factory or field applied sealant in the seam is optional.


SYSTEM LIMITATIONS

- 2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners).
- **3.** Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133.
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, city, state, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.








ISOMETRIC VIEW




ISOMETRIC VIEW
