- 1. Tri-Flex XT® Roofing Underlayment shall be installed in strict compliance with applicable Building Code.
- 2. Tri-Flex XT[®] Roofing Underlayment shall be installed with a minimum 4-inch head lap in a shingle layer fashion and be fastened as specified in Florida Building Code, Building volume 1518.2
- **3.** Tri-Flex XT® Roofing Underlayment is a component used in roof assemblies. Roof assemblies are approved under specific assembly Notice of Acceptance.
- **4.** Tri-Flex XT® Roofing Underlayment may be used with Asphalt shingles, Wood shakes and shingles, Non-structural metal roofing, and quarry slate. Tri-Flex XT® Roofing Underlayment shall not be used as roof tile underlayment.
- 5. Tri-Flex XT® Roofing Underlayment may be used with any approved roof covering Notice of Acceptance listing Tri-Flex XT® Roofing Underlayment as a component part of an assembly in the Notice of Acceptance. If Tri-Flex XT® Roofing Underlayment are not listed, a request may be made to the Authority Having Jurisdiction (AHJ) or the Miami-Dade County Product Control Department for approval provided that appropriate documentation is provided to detail compatibility of the products, wind uplift resistance, and fire testing results.
- **6.** For fire classification of specific roof assemblies using Tri-Flex XT® Roofing Underlayment refer to a current Approved Roofing Materials Directory for fire ratings of this product.

LABELING:

All membranes or packaging shall bear the imprint or identifiable marking of the manufacturer's name or logo, manufacturing location, and the following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.

- Fire classification is not part of this acceptance, refer to a current Approved Roofing Materials Directory for fire ratings of this product
- 2. This acceptance is for prepared roofing applications. Minimum deck requirements shall be in compliance with applicable building code.
- Tri-Flex XT® Roofing Underlayment shall be applied to a smooth, clean and dry surface with deck free of 3. irregularities. All nails in the deck shall be carefully checked for protruding heads. Re-fasten any loose decking panels. Sweep the deck thoroughly to remove any dust and debris prior to application.
- 4. Tri-Flex XT® Roofing Underlayment shall not be hot mopped, refer to manufacturer's published literature for product compatibility.
- Tri-Flex XT® Roofing Underlayment shall not be left exposed as a temporary roof for longer than 30 days of 5. application.
- 6. Tri-Flex XT® Roofing Underlayment shall not be applied over an existing roof membrane as a recover system.
- 7. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
