Deck Type 1:	Concrete Decks, Non-Insulated
Deck Description:	Min. 2500 psi concrete
System Type F:	Waterproofing Membrane
Surface Condition:	All surfaces must be free from dirt, grease, oil, dust and other contaminants. New concrete must be cured 14-28 days. Surface preparation and repair requirements should comply with the manufacturer published specification guidelines.
Base Coat:	Apply Basecrete mix with Basecrete Flexible Waterproofing Bond using a ¾" nap roller, trowel, spray or squeegee in two 1/16" thick coats for a total of 1/8" thickness. Allow 24 hours to cure.
Top Coat:	Apply Basecrete mix with Basecrete Flexible Waterproofing Bond using a ¾" nap roller, trowel, spray or squeegee in two 1/16" thick coats for a total of 1/8" thickness. Allow 24 hours to cure.
Integrity Test:	Required, and shall be performed in accordance with ASTM D 5957 by an approved lab. Water may be maintained for a period longer than 24 hours if required.
Inspection:	Contractor and a representative of the membrane manufacturer shall inspect the waterproofing assembly and notify the contractor of any defects. All defects shall be corrected.
Overburden (Optional):	<p>Minimum 12" x 12" x 2" Concrete Pavers shall be placed over the cured top coat and adhered using ANSI A118.1 mortar installed using a ¼" notched trowel. Overburden shall be allowed to cure for 28 days.</p> <p>Or</p> <p>Minimum 12" x 12" x 0.5" Ceramic tiles shall be placed over the cured top coat and adhered using ANSI A118.1 mortar installed using a ¼" notched trowel. Overburden shall be allowed to cure for 28 days.</p>
Maximum Design Pressure:	<p>-502.5 psf. with Concrete Pavers Overburden (See General Limitation #9.)</p> <p>-502.5 psf. with Ceramic Tile Overburden (See General Limitation #9.)</p> <p>-502.5 psf. with No Overburden (See General Limitation #9.)</p>



GENERAL LIMITATIONS:

1. Fire classification is not part of this acceptance, refer to a current Approved Roofing Materials Directory for fire ratings of this product.
2. A copy of the integrity test report described herein in accordance with ASTM D5957 from an approved lab shall be provided to the Building Official for review at time of final inspection.
3. Contractor shall submit to the Building Official for review the system specifications and details. Submission of these documents, as well as the proper application and installation of all materials shall be the sole responsibility of the contractor.
4. Flashings shall be installed according to the manufacturers published standard details, specific details, approved by Basecrete Technologies and shall be submitted to the Building Official for review.
5. All work shall be performed by a Contractor licensed to do roofing/ waterproofing and be a Manufacturer Trained 'Qualified Applicator' approved and licensed by Basecrete Technologies. Basecrete Technologies shall supply a list of approved applicators to the authority having jurisdiction.
6. Systems shall not be installed over lightweight insulating concrete.
7. Perimeter and corner areas shall comply with the enhanced uplift pressure requirements of these areas. Fastener densities shall be increased for both insulation and base sheet as calculated in compliance with Roofing Application Standard RAS 117. Calculations prepared, signed and sealed by a Florida registered Professional Engineer, Registered Architect, or Registered Roof Consultant **(When this limitation is specifically referred within this NOA, General Limitation #9 will not be applicable.)**
8. All attachment and sizing of perimeter nailers, metal profile, and/or flashing termination designs shall conform with Roofing Application Standard RAS 111 and the wind load requirements of applicable Building Code.
9. The maximum designed pressure limitation listed shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners). **(When this limitation is specifically referred within this NOA, General Limitation #7 will not be applicable.)**
10. A non-skid surfacing is required for all pedestrian areas, plaza decks or balconies.
11. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
