Description A single-component, aliphatic polyurethane coating applied membrane to the following

substrates at an application rate of:

• <u>Spray Polyurethane Foam</u>: Apply 70620-CA base coat at a minimum rate of 1.5 gal./100ft² to yield an average thickness of 24 wet mils followed by **7490-CA** at a minimum rate of 1.5 gal./100ft² to yield an average thickness of 24 wet mils of the topcoat.

- SBS or APP Granular Modified Bitumen: Apply 7780/7781 primer at a minimum rate of .33 gal./100ft² followed by two coats of 70620-CA base coat each applied at a minimum rate of 1.0 gal./100ft² to yield an average thickness of 16 wet mils per coat followed by **7490-CA** at a minimum rate of 1.66 gal./100ft² to yield an average thickness of 24 wet mils of the topcoat.
- <u>EPDM</u>: Apply 7780/7781 primer at a minimum rate of .25 gal./100ft² followed by 70620-CA base coat at a minimum rate of 1.5 gal./100ft² to yield an average thickness of 24 wet mils followed by **7490-CA** at a minimum rate of 1.5 gal./100ft² to yield an average thickness of 24 wet mils of the topcoat.
- <u>Hypalon</u>: Apply 7797/7798 primer at a minimum rate of .25 gal./100ft² followed by 70620-CA base coat at a minimum rate of 1.5 gal./100ft² to yield an average thickness of 24 wet mils followed by **7490-CA** at a minimum rate of 1.5 gal./100ft² to yield an average thickness of 24 wet mils of the topcoat.
- <u>Concrete</u>*: Apply 7797/7798 primer at a minimum rate of .33 gal./100ft² followed by 70620-CA base coat at a minimum rate of 1.5 gal./100ft² to yield an average thickness of 24 wet mils followed by **7490-CA** at a minimum rate of 1.5 gal./100ft² to yield an average thickness of 24 wet mils of the topcoat.
