Deck Type:	Wood, Non-Insulated		
Deck Description:	New Construction or Re-roof $^{15}/_{32}$ " or greater plywood or wood plank.		
Slope Range:	2": 12" or greater		
Maximum Uplift Pressure:	See Table A below		
Deck Attachment:	In accordance with applicable Building Code, but in no case shall it be less than 8d annular ring shank nails spaced 6" o.c. In reroofing, where the deck is less than $^{19}/_{32}$ " thick (Minimum $^{15}/_{32}$ "). The above attachment method must be in addition to existing attachment.		
Underlayment:	Minimum underlayment shall be a ASTM D 226 Type II installed with a minimum 4" side- laps and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 1¼" annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll. Or, any Miami-Dade County Product Control Approved underlayment having a current NOA.		
Fire Barrier:	Any approved fire barrier having a current NOA. Refer to a current fire directory listing or current ASTM E 108 fire test for fire ratings of this roofing system assembly as well as the location of the fire barrier within the assembly. See Limitation $#$ 1.		
Valleys:	Valley construction shall be in compliance with Roofing Application Standard RAS 133 and with Berridge Manufacturing company's current published installation instructions.		
Metal Panels and Accessories:	Install the "Cee-Lock Steel Roof Panel" and accessories in compliance with Berridge Manufacturing Company's current published installation instructions and details. Flashing, penetrations, valley construction and other details shall be constructed in compliance with the minimum requirements provided in Roofing Application Standards RAS 133.		
	"Cee-Lock" Roof Panels shall be attached to the plywood substrate along its male rib using the approved clips (continuous, 24-ga). Each clip shall be attached to the substrate with corrosion resistant #10-13 pancake head screws of sufficient length to penetrate through the sheathing a minimum of 3/16" at a spacing as listed in Table A below.

- 2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners).
- 3. Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.







CEE-LOCK PANEL PROFILE


TYPICAL FASTENER PATTERN ACROSS WIDTH
