Deck Type:	Wood, Non-Insulated		
Deck Description:	New Construction 19/32" or greater plywood or wood plank, or for re-roofing 15/32" or greater plywood.		
Slope Range:	2": 12" or greater		
Maximum Uplift Pressure:	See Table A below		
Deck Attachment:	In accordance with applicable Building Code, but in no case shall it be less than 8d ring shank nails spaced 6" o.c. In reroofing, where the deck is less than 19/32" thick (Minimum 15/32") The above attachment method must be in addition to existing attachment.		
Underlayment:	Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4" side- lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 12 gauge 1 <sup>1</sup> / <sub>4</sub> " annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll. Or, any approved underlayment having a current NOA.		
	Apply a full width of a Miami Dade Approved ASTM D 1970 self-adhered underlayment along the eaves, rakes, and valley.		
Fire Barrier:	Any approved fire barrier having a current NOA. Refer to a current fire directory listing for fire ratings of this roofing system assembly as well as the location of the fire barrier within the assembly. See Limitation # 1.		
Valleys:	Valley construction shall be in compliance with Roofing Application Standard RAS 133 and with PAC Contractors Association's current published installation instructions.		
Metal Panels and Accessories:	Install the "Q-150 Panel" and accessories in compliance with the current published installation instructions and details in PAC Contractors Association's Installation Manual. Flashings, penetrations, valley construction and other details shall be constructed in compliance with Roofing Application Standard RAS 133.		
	Panels shall be secured at a spacing listed below in <b>Table A</b> with #10 pancake head screws of sufficient length to penetrate through the sheathing a minimum $^{3}/_{16}$ of an inch.		
	The adjacent panel shall overlap and be secured to each other when the female rib of panel is snapped over the male rib of panel.


## SYSTEM LIMITATIONS

- 2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e., field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e., perimeters, extended corners and corners).
- **3.** Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, and the following statement: "Miami-Dade County Product Control Approved" **or** with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




- 5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule **61G20-3** of the Florida Administrative Code.
