System A-1:	Advantagelok II Metal Panel
Deck Type:	Wood, Non-Insulated
<b>Deck Description:</b>	$^{19}/_{32}$ " or greater plywood or wood plank.
Slope Range:	2": 12" or greater
Maximum Uplift Pressure:	See Table A below
Deck Attachment:	In accordance with applicable Building Code, but in no case shall it be less than 8d annular ring shank nails spaced 6" o.c. In reroofing, where the deck is less than $^{19}/_{32}$ " thick (Minimum $^{15}/_{32}$ "). The above attachment method must be in addition to existing attachment.
Underlayment:	Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4" side-laps and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 1¼" annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll. Or, any Miami-Dade County Product Control Approved underlayment having a current NOA.
Fire Barrier Board:	Any approved fire barrier having a current NOA. Refer to a current fire directory listing for fire ratings of this roofing system assembly as well as the location of the fire barrier within the assembly. See Limitation # 1.
Valleys:	Valley construction shall be in compliance with Roofing Application Standard RAS 133 and with Union Corrugating Company's current published installation instructions.
Metal Panels and Accessories:	Install the "AdvantageLok II Metal Roofing Panel" and accessories in compliance with Union Corrugating Company's current published installation instructions and details. Flashing, penetrations, valley construction and other details shall be constructed in compliance with the minimum requirements provided in Roofing Application Standards RAS 133.
Field Condition:	AdvantageLok II Metal Roofing Panels shall be fastened with a minimum of #10-12 x 1" A-point pancake head corrosion resistant fasteners spaced 9.25" o.c. Fasteners shall of sufficient length to penetrate through the sheathing a minimum of $^{3}/_{16}$ ". <i>Maximum Design Pressure: - 63.5 psf (See General Limitation #2)</i>
	Maximum Design Fressure: - 65.5 psj (See General Limitation #2)
Perimeter and Corner Condition Option #1:	AdvantageLok II Metal Roofing Panels shall be fastened with a minimum of #10-12 x 1" A-point pancake head corrosion resistant fasteners spaced 4.625" o.c. Fasteners shall of sufficient length to penetrate through the sheathing a minimum of ${}^{3}/{}_{16}$ ".
	Maximum Design Pressure: - 78.5 psf (See General Limitation #2)

	For Perimeter and Corners, use a 3/16" bead of SikaFlex 201 Sealant as shown in Detail B.
	Maximum Design Pressure: - 97 psf (See General Limitation #2)
Perimeter and Corner Condition Option #3:	AdvantageLok II Metal Roofing Panels shall be fastened with a minimum of #10-12 x 1" A-point pancake head corrosion resistant fasteners spaced 4.625" o.c. Fasteners shall of sufficient length to penetrate through the sheathing a minimum of $^{3}/_{16}$ ".
	For Perimeter and Corners, use a 3/16" bead of SikaFlex 201 Sealant as shown in Detail B.
	Retainer strap shall be installed in the center below each panel with #10-12 x 1" pancake head screws that are staggered at 6" o.c. on both sides of the strap. On top of the strap, place 2 continuous 3/8" beads of Bostik 915 Adhesive. See Detail C.
	Maximum Design Pressure: - 131.5 psf (See General Limitation #2)



## SYSTEM LIMITATIONS

- 1. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire ratings of this product.
- 2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners).
- **3.** Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, and the following statement: "Miami-Dade County Product Control Approved" **or** with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.


