Valleys:	Valley construction shall be in compliance with Roofing Application Standard RAS 133 an with the current published installation instructions and details in PAC Contractor Association's Roofing Installation Manual.		
Metal Panels and Accessories:	Install the "Snap-Clad 0.032" x 12"-18" Wide Aluminum Panel " panels including flashin penetrations, valleys, end laps and accessories in compliance PAC Contractors Association' current, published installation instructions and in compliance with the minimum requirement detailed in Roofing Application Standard RAS 133.		
	Panels shall be installed along the rib with SNAP CLAD Clips secured with #10 pancak head screws (2 per clip); the screws shall be of sufficient length to penetrate through th sheathing a minimum of $^{3}/_{16}$ ". The female rib of panel is snapped over the male rib of panel Panel clips shall be spaced a maximum distance listed below in <b>Table A</b> .

- **3.** Panels may be roll formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133.
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, city, state, and the following statement: "Miami-Dade County Product Control Approved" **or** with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.



- 5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule **61G20-3** of the Florida Administrative Code.
- 6. Panels may be shop or jobsite roll formed with machine model #'s <u>7291017 and 01110073</u> from PAC Contractors Association.






