3. LIMITATIONS:

- **3.1** Fire classification is not part of this acceptance.
- **3.2** For mortar or adhesive set tile applications, a static field uplift test in accordance with TAS 106 may required, refer to applicable building code.
- **3.3** Applicant shall retain the services of a Miami-Dade County Certified Laboratory to perform quarterly test in accordance with TAS 112, appendix 'A'. Such testing shall be submitted to the Regulatory and Economic Development Department Product Control Section for review.
- **3.4** Minimum underlayment shall be in compliance with the applicable Roofing Applications Standards listed section 4.1 herein.
- **3.5** 30/90 hot mopped underlayment applications may be installed perpendicular to the roof slope unless stated otherwise by the underlayment material manufacturers published literature.
- **3.6** This acceptance is for wood deck applications. Minimum deck requirements shall be in compliance with applicable building code.

4. INSTALLATION

- **4.1** Plasma Clay Roof Tile and its components shall be installed in strict compliance with Roofing Application Standard RAS-120.


LABEL FOR PLASMA CLAY ROOF TILE (LOCATED ON THE SIDE OF TILE)


6. **BUILDING PERMIT REQUIREMENTS:**
