minimum requirements detailed in Roofing Application Standard RAS 133.

Panels shall be secured along the male rib with approved clips and two corrosion resistant #10 pancake head fasteners of sufficient length to penetrate through the sheathing a minimum of $^{3}/_{16}$ ". The panel clips were placed at a spacing listed below in **Table A** starting 3" from panel end. A bead of an approved sealant with current NOA shall be applied at the end of

each panel seam. The female rib of panel is snapped over the male rib of panel.

All panels shall be permanently labeled with the manufacturer's name and/or logo, city and state, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




- 5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule **61G20-3** of the Florida Administrative Code.
- **6.** Panels may be jobsite roll formed with machine model #'s <u>9750606</u> from DMC Association of Regional Manufacturers.


