INSTALLATION:

1. LTC Quality Plus D90 shall be installed in strict compliance with the applicable Building Code.
2. LTC Quality Plus D90 shall be installed with a minimum 4-inch horizontal lap and 6-inch vertical laps in shingle layer fashion.
3. LTC Quality Plus D90 shall be fastened with approved corrosion resistant 1 ⁵/₈" tin-caps and 12 gauge 1 ¹/₄" annular ring-shank nails, spaced 6" o.c. at all laps and evenly staggered rows in a grid pattern spaced 12" o.c. in the field of the roll.
4. LTC Quality Plus D90 may be used with asphaltic shingles, wood shakes and shingles, non-structural metal roofing and slate or simulated slate roof assemblies.
5. For fire classification of specific roof assemblies using LTC Quality Plus D90 refer to a current Approved Roofing Materials Directory for fire ratings of this product.

LIMITATIONS:

1. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire ratings of this product.
2. LTC Quality Plus D90 underlayment is designed for use as specified within approved roofing system NOA assemblies that specify the product within the Product Approval assembly.
3. This acceptance establishes the required physical properties testing and traceability of roofing membrane and accessory components listed in approved roofing applications. Minimum deck requirements shall be in compliance with applicable building code. LTC Quality Plus D90 underlayment shall be installed in strict compliance with applicable Building Codes, Product Approvals and Manufacturers' specifications and guidelines.
4. LTC Quality Plus D90 underlayment shall be applied to a smooth, clean and dry surface with deck free of irregularities. All nails in the deck shall be carefully checked for protruding heads. Re-fasten any loose decking panels. Sweep the deck thoroughly to remove any dust and debris prior to application.
5. LTC Quality Plus D90 underlayment shall not be hot mopped, refer to manufacturer's published literature for product compatibility.
6. LTC Quality Plus D90 shall be an acceptable underlayment for asphaltic shingles, wood shakes and shingles, non-structural metal roofing and slate or simulated slate roof assemblies.
7. LTC Quality Plus D90 underlayment shall not be left exposed as a temporary roof for longer than 90 days of application.
8. Change in materials or manufacturing process or location of any of the products listed herein shall be cause for termination of this Notice of Acceptance.
9. LTC Quality Plus D90 underlayment may be used with any approved Roof Assembly Notice of Acceptance listing LTC Quality Plus D90 underlayment as a component part of an assembly in the Notice of Acceptance. If LTC Quality Plus D90 underlayments is not listed; a request may be made to the Authority Having Jurisdiction (AHJ) or the Miami-Dade County Product Control Department for approval provided that appropriate documentation is provided to detail compatibility of the products, wind uplift resistance, and fire testing results.
10. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
