Trade Name: Xtractor Vent XLP Turbo

System Type A: Mechanical attachment of vent over asphaltic shingles roof systems.

Slot: Cut a slot in the wood deck sheathing along roof ridge 1 ½" wide (¾" on each side). If ridge

beam is present, cut slot 3/4" wide on each side of ridge beam. The slot shall terminate a minimum

of 12" at both ends of the ridge.

Installation: Place beginning end of vent 1" in from gable end and use centering line for proper alignment

along peak. Fasten using at least two nails at each end in nail line area (1 ¾" minimum nail length), then continue to nail approximately every 12 inches. More nails may be required on steeper slopes to seat properly. Continue installing additional rolls as needed along ridge aligning end to end, aligning centering line. When reaching the other end, cut vent roll to 1" form the gable end and nail in place. End plugs are provided every 12" on the underside of the product.

Ridge Shingles: Place first cap shingle over vent so that it overhangs at least 1" over end of vent roll. Install with

approved nails that penetrate sheathing at least - " in nail line area as you work your way along

the roof ridge. Cut last cap shingle so that it overhangs vent 1" at other gable end.

Ridge shingles shall be installed in accordance to a current and approved Notice of Acceptance.

Trade Name: CoolRidge Sectional Ridge Vent

System Type A: Mechanical attachment of vent over asphaltic shingles roof systems.

Slot: Cut a slot in the wood deck sheathing along roof ridge 2" wide (1" on each side). The slot shall

terminate a minimum of 12" at both ends of the ridge.

Installation: Place first piece of vent with female end 1" from gable end and use centering line for proper

alignment along peak. Fasten each vent section to the deck with (6) 12 gage, 2 ½" long galvanized ring shank nails placed approximately 1" from the ends of each vent section and in the middle along the manufacturer's nail line. Nails shall be of sufficient length to penetrate through the

sheathing a minimum of $^{3}/_{16}$ ".

Continue installing additional vent sections along the ridge, as described above, sliding female

ends over male ends. Align vent sections using centering line.

The last vent section may need to be cut to length. End plugs are provided every 12" on underside of the vent. Measure amount needed to install vent to within 1" of gable end. Cut the vent section to length and flip so that end plug is at gable end. Allow male end from previous piece to slide

under the last vent section and nail in place as described above.

Ridge Shingles: Cover the vent with 12" wide ridge shingles. Each ridge shingle shall be fastened through the vent

to the deck along the manufacturer marked nail line with (2) 12 gage, 2 ½" long galvanized ring shank nails. Nails shall be of sufficient length to penetrate through the sheathing a minimum of

 $^{3}/_{16}$ ".

Ridge shingles shall be installed in accordance to a current and approved Notice of Acceptance.

- 2. The installation shall be applied in compliance with the manufacturer's current published application instruction and the requirements set forth in the applicable Building Code.
- **3.** Xtractor Vent XLP Turbo and CoolRidge Sectional Ridge Vent are approved to be installed on asphaltic roof shingle systems only.
- **4.** Xtractor Vent XLP Turbo and CoolRidge Sectional Ridge Vent shall not be installed on roof mean heights greater than 33 ft.
- **5.** All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
- 6. All plastic ridge vent manufacturers shall have an unannounced follow-up quality control program from an approved listing agency. Follow-up test results shall be made available to the Miami Dade Product Control Section upon request.
- 7. All approved products listed herein shall be labeled and shall bear the imprint or identifiable marking of the manufacturer's name or logo, city and state of manufacturing facility, and the following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.





XTRACTOR VENT XLP TURBO RIDGE BEAM INSTALLATION







