First Coat:	ERSystems [®] Polyurethane 300 Aromatic Basecoat shall be applied to the entire substrate in two coats at a rate of 1.5 to 2.0 gal/sq (50ft ² -70ft ² /gal).
Second Coat:	ERSystems® Polyurethane 300 Aliphatic Finish Coat shall be applied in one coat at a rate of 1.0gal/sq (100ft ² /gal).
Substrate:	New or Existing EPDM, TPO, PVC & KEE Membranes
Preparations:	The surface shall be clean, sound and dry prior to application. Detail seams, laps and penetrations with ERSystem [®] polyurethane sealant.
First Coat:	ERSystems [®] Polyurethane 300 Aromatic Basecoat shall be applied to the entire substrate at a rate of 1.0 gal/sq (100ft ² /gal).

Preparations:	The surface shall be clean, sound and dry prior to application. Tighten or replace existing fasteners, prime rusted areas with ERSystems [®] Polyurethane Metal Rust Primer. Detail all seams and fasteners with ERSystems [®] HER polyurethane sealant.
First Coat:	ERSystems [®] Polyurethane 300 Aromatic Basecoat shall be applied to the entire substrate at a rate of 1.0 gal/sq (100ft ² /gal).

Primer:	Pacific Polymers [®] Elasto-Poxy Primer VOC shall be applied to the entire substrate at a rate of 1/3 to 1/2 gal/sq (200ft ² -300ft ² /gal).
First coat:	ERSystems [®] Polyurethane 300 Aromatic Basecoat shall be applied to the entire substrate in one to two coats at a rate of 1.5 to 2.0 gal/sq (50ft ² -70ft ² /gal)
Second coat:	ERSystems[®] Polyurethane 300 Aliphatic Finish Coat shall be applied to the entire substrate at a rate of 1.0 gal/sq (100ft ² /gal).

- 5. Change in materials, use, or manufacture of any products listed herein shall be cause for termination of this Notice of Acceptance.
- 6. ERSystems[®] Polyurethane 300 System shall be applied in accordance with manufacturer's published application instructions.
- 7. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
- 8. The use of a reinforcing fabric in a maintenance coating is only to enhance the coating's ability to deliver efficient long term performance through the protection of the underlying roof system and in this particular use does not become a roof system itself.
- **9.** All approved products listed herein shall be labeled in compliance with TAS 121 and shall bear the imprint or identifiable marking of the manufacturer's name or logo, city and state of manufacturing facility, and following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.
