Panels shall be secured along the male rib with approved clips and two corrosion resistant #10 pancake head fasteners of sufficient length to penetrate through the sheathing a minimum of $^{3}/_{16}$ ". The panel clips were placed at a spacing listed in **Table A** below starting 3" from

panel end. The female rib of panel is snapped over the male rib of panel.

All panels shall be permanently labeled with the manufacturer's name and/or logo, city and state, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




- 5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
- **6.** Panels may be jobsite roll formed with machine model #('s) MPJ5610123 from DMC Association of Regional Manufacturers.


