Deck Type:	Wood, Non-insulated New Construction $^{19}/_{32}$ " or greater plywood or wood plank, or for re-roofing 15/32" or greater plywood.

	Panels shall be installed along the rib with SNAP CLAD Clips secured with #10 fasteners (2 per clip for individual clip; 8 per clip for continuous clip); the screws shall be of sufficient length to penetrate through the sheathing a minimum of $3/16$ ". The female rib of panel is snapped over the male rib of panel. Panel clips shall be spaced a maximum distance listed below in Table A .


- 1. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire ratings of this product.
- 2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e., field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e., perimeters, extended corners and corners).
- **3.** Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133.
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, city, state, and the following statement: "Miami-Dade County Product Control Approved" **or** with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.
