# **INSTALLATION:**

- 1. National Nail Synthetic Underlayments shall be installed in strict compliance with applicable Building Code requirements with prescribed approved fasteners and fastener densities.
- 2. National Nail Synthetic Underlayments shall be installed with a minimum 4-inch head lap in a single layer fashion and a 12" end lap where required as specified by manufacturer's specifications.
- 3. National Nail Synthetic Underlayments shall be fastened with corrosion resistant tin-caps and 12 gauge, 1-1/4" annular ring-shank nails, spaced 6" o.c. at all laps and staggered rows fastened 12" o.c. in the field of the roll at a row spacing of 12 inches on center. For the 48-inch roll a minimum of four rows of fasteners spaced as previously specified is required.
- 4. National Nail Synthetic Underlayments may be used with Asphaltic shingles, Wood shakes and shingles, Nonstructural metal roofing, and quarry slate.

# LABELING:

All membranes or packaging shall bear the imprint or identifiable marking of the manufacturer's name or logo, city, state and the following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.



# LIMITATIONS:

- 1. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire rating of this product.
- 2. National Nail Synthetic Underlayments are components used in roof assemblies. Roof assemblies are approved under specific roof system Notice of Acceptance.
- 3. National Nail Synthetic Underlayments shall be applied in strict compliance with applicable building code to a smooth, clean and dry surface. This acceptance is for prepared roofing applications. Minimum deck requirements shall be in compliance with the applicable building code and be free of irregularities.
- 4. National Nail Synthetic Underlayments shall not be used in Roof Tile assemblies, nor shall they be hot mopped or be applied over a pre-existing roof membrane as a recover system, refer to manufacturer's literature for product compatibility.
- 5. EXO 50 and EXO 35 shall not be left exposed as a temporary roof for longer than 30 days of application.
- 6. EXO-25 SB shall not be left exposed as a temporary roof for longer than 90 days of application.
- 7. National Nail Synthetic Underlayments may be used with any approved roof covering Notice of Acceptance listing the National Nail Synthetic Underlayments as a component part of an assembly in the Notice of Acceptance. If the National Nail Synthetic Underlayments are not listed, a request may be made to the Authority Having Jurisdiction (AHJ) or Miami-Dade County Product Control Department for approval provided that appropriate documentation is provided to detail compatibility of the products, wind uplift resistance, and fire testing results.
- 8. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
