snapped over the male rib of panel.

All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




- 5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
- **6.** Panels may be shop or jobsite roll formed with machine model #('s) **SSH4350721** from PAC Contractors Association.


