Shingles shall be labeled with the Miami-Dade Approved Seal as seen below, or the wording "Miami-Dade County-Product Control Approved".









DETAIL B ELITE GLASS-SEAL HIP AND RIDGE SHINGLE





Heritage Vintage 12 x 12 Hip and Ridge




12-1/4 x 12 HIP AND RIDGE SHINGLE AND 12-1/4 x 12 HERITAGE HIP AND RIDGE IR
