System:	PAC-150 0.032in.(min) x 12in. thru 20in. Wide Aluminum Panels over Plywood
Deck Type:	Wood, Non-insulated
Deck Description:	New Construction ¹⁹ / ₃₂ " or greater plywood or wood plank, or for re-roofing ¹⁵ / ₃₂ " or greater plywood.
Slope Range:	1": 12" or greater
Maximum Uplift Pressure:	See Table A below

Deck Attachment:	In accordance with applicable Building Code, but in no case shall it be less than 8d annular ring shank nails spaced 6" o.c. In reroofing, where the deck is less than ¹⁹ / ₃₂ " thick (Minimum ¹⁵ / ₃₂ ") The above attachment method must be in addition to existing attachment.
Underlayment:	Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4" side-lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 12 gauge 1 1/4" annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll or any approved underlayment having a current NOA.
Fire Barrier:	Any approved fire barrier having a current NOA. Refer to a current fire directory listing for fire ratings of this roofing system assembly as well as the location of the fire barrier within the assembly. See Limitation # 1.
Valleys:	Valley construction shall be in compliance with Roofing Application Standard RAS 133 and with the current published installation instructions and details in PAC Contractors Association's Installation Manual.
Metal Panels and Accessories:	<p>Install the "PAC-150 1.5 Aluminum Panel" including flashing penetrations, valleys, end laps and accessories in compliance "PAC Contractors Association's" current, published installation instructions and in compliance with the minimum requirements detailed in Roofing Application Standard RAS 133.</p> <p>Panels shall be secured along the male rib with approved clips (PAC-150 Fixed Clip or PAC-150 Sliding Clip) and two corrosion resistant #10 x 1 1/2" pancake head screws of sufficient length to penetrate through the sheathing a minimum of ³/₁₆". When using the PAC-150 Sliding Clip, screws must be installed in the outer holes of the base. The panel clips were placed at a spacing listed in Table A below. The female rib of panel is installed over the male rib of panel. Panels are seamed as listed below in Table A.</p>

LIMITATIONS

1. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire ratings of this product.
2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners).
3. Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133.
4. All panels shall be permanently labeled with the manufacturer's name and/or logo, city, state, and the following statement: "Miami-Dade County Product Control Approved" **or** with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.

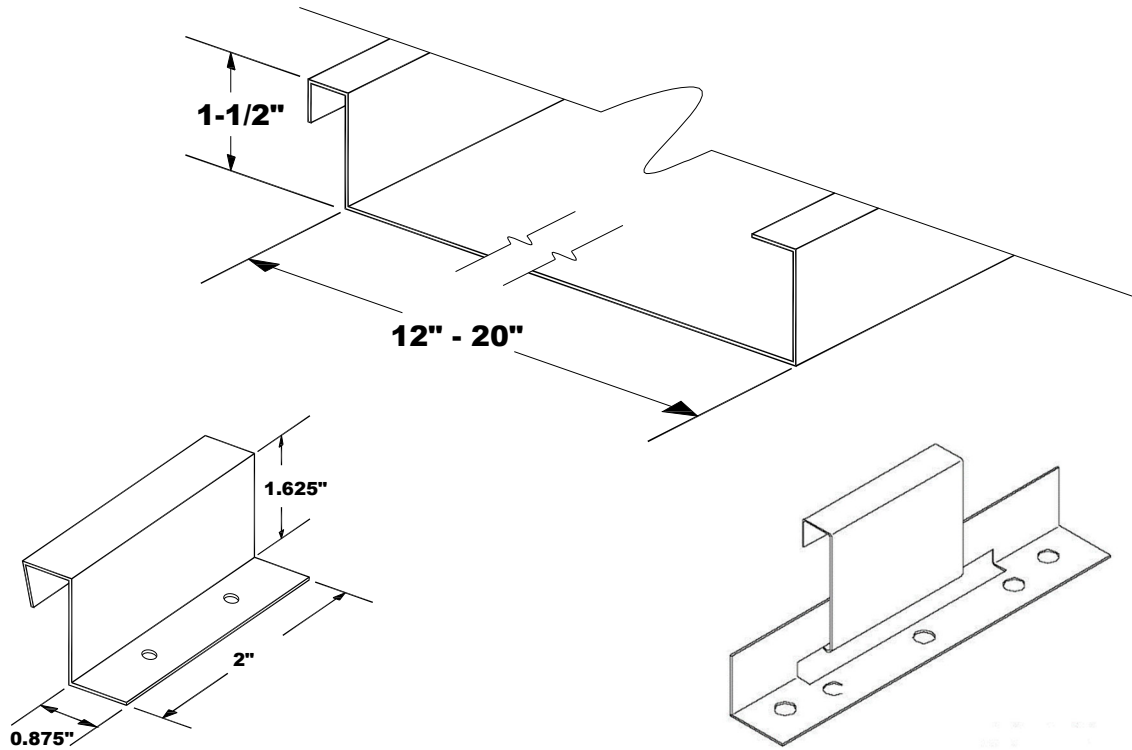


5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule **61G20-3** of the Florida Administrative Code.
6. Panels may be shop or jobsite roll formed with machine model #(’s) **7090201** and **Q4110340** from PAC Contractors Association.



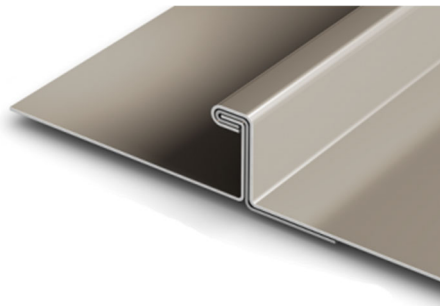
PROFILE DRAWINGS

CLIP RELIEFS, STIFFENING RIBS AND STRIATIONS ARE OPTIONAL

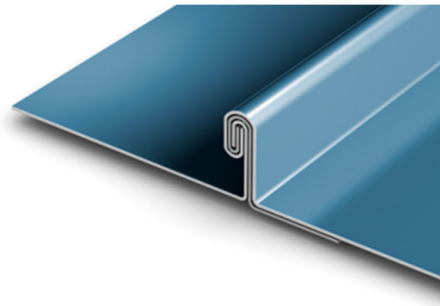


PAC-150 FIXED CLIP
