System: Englert Series 2000 Aluminum Panel

Deck Description: New Construction $^{19}/_{32}$ " or greater plywood or wood plank.

Deck Attachment: In accordance with applicable Building Code, but in no case shall it be less than 8d annular

ring shank nails spaced 6" o.c. In reroofing, where the deck is less than ¹⁹/₃₂" thick (Minimum

 $^{15}/_{32}$ "). The above attachment method must be in addition to existing attachment.

Underlayment: Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4" side-

laps and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 11/4" annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll. Or, any Miami-Dade County Product Control Approved underlayment

having a current NOA.

Fire Barrier Board: Any approved fire barrier having a current NOA. Refer to a current fire directory listing for

fire ratings of this roofing system assembly as well as the location of the fire barrier within

the assembly. See Limitation # 1.

Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133 and

with Englert's current published installation instructions.

Metal Panels and

Accessories:

Install the "Series 2000 Panel" and accessories in compliance with the current published installation instructions and details in Englert's Installation Manual. Flashings, penetrations, valley construction and other details shall be constructed in compliance with Roofing

Application Standard RAS 133.

Panels shall be installed with galvanize steel clips ($3\frac{1}{2}$ " long x 2 $\frac{1}{2}$ " wide x $1\frac{3}{4}$ " tall), attached to substrate with (2) two corrosion resistant #10-13 pancake head wood screws of sufficient length to penetrate through the sheathing a minimum of $\frac{3}{16}$ ". Clip fastening shall start 8"

from panel end and shall be at maximum spacing as described below in **Table A**.

- **3.** Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133
- 4. All panels shall be permanently labeled with the manufacturer's name and/ or logo, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




- 5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule **61G20-3** of the Florida Administrative Code.
- **6.** Panels may be jobsite roll formed with machine model #('s) <u>052303</u> from Englert Rollformed Products Association.


