Field Conditions: Panels shall be secured along the male rib with corrosion resistant #10-13 x 1" PHW fasteners

of sufficient length to penetrate through the sheathing a minimum of $\frac{3}{16}$ " and located at the

maximum spacing listed in Table A below. See Detail B herein.

The adjacent panel shall overlap and be secured to each other when the female rib of the panel

is snapped over the male rib of panel.









DMC 100NS - 24GA, STEEL PANEL


