Deck Type:	Wood, Non-insulated	
Deck Description:	New Construction $\frac{19}{32}$ " or greater plywood or wood plank.	
Slope Range:	2": 12" or greater	
Maximum Uplift Pressure:	See Table A Below	
Deck Attachment:	In accordance with applicable Building Code, but in no case shall it be less than 8d annular ring shank nails spaced 6" o.c. 	Apply one layer of a MetShield HT self-adhered underlayment over the ASTM D 226 Type II.

Metal Panels and Accessories:	Install the "DMC 175 S - 0.032" Aluminum Panel " panels including flashing penetrations, valleys, end laps and accessories in compliance "DMC Association of Regional Manufacturers" current, published installation instructions and in compliance with the minimum requirements detailed in Roofing Application Standard RAS 133.	
	Panels shall be secured along the male rib with approved clips and two corrosion resistant #10 pancake head fasteners of sufficient length to penetrate through the sheathing a minimum of ${}^{3}/{}_{16}$ ". The panel clips were placed at a spacing listed below in Table A starting 3" from panel end. A bead of an approved sealant with current NOA shall be applied at the end of each panel seam. The female rib of panel is snapped over the male rib of panel.


- 1. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire ratings of this product.
- 2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e., field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e., perimeters, extended corners and corners).
- **3.** Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, city and state, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.



- 5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule **61G20-3** of the Florida Administrative Code.
