RENEWAL of this NOA shall be considered after a renewal application has been filed and there has been no change in the applicable building code negatively affecting the performance of this product.



BUILDING PERMIT REQUIREMENTS:

Application for building permit shall be accompanied by copies of the following:

- 1. This Notice of Acceptance.
- 2. Any other documents required by the Building Official or applicable building code in order to properly evaluate the installation of this material.

INSTALLATION:

- 1. VanBoxel Building Supply Underlayment shall be installed in strict compliance with applicable Building Code requirements with prescribed approved fasteners and fastener densities.
- 2. VanBoxel Building Supply Underlayment shall be installed with a minimum 4-inch head lap in a single layer fashion and a 12" end lap where required as specified by manufacturer's specifications.
- 3. VanBoxel Building Supply Underlayment shall be fastened with corrosion resistant tin-caps and 12 gauge, 1-1/4" annular ring-shank nails, spaced 6" o.c. at all laps and staggered rows fastened 12" o.c. in the field of the roll at a row spacing of 12 inches on center. For the 48-inch roll a minimum of four rows of fasteners spaced as previously specified is required.
- 4. VanBoxel Building Supply Underlayment may be used with Asphaltic shingles, Wood shakes and shingles, Nonstructural metal roofing, and quarry slate.

LIMITATIONS:

- 1. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire rating of this product.
- 2. VanBoxel Building Supply Underlayment is a component used in roof assemblies. Roof assemblies are approved under specific roof system Notice of Acceptance.
- 3. VanBoxel Building Supply Underlayment shall be applied in strict compliance with applicable building code to a smooth, clean and dry surface. This acceptance is for prepared roofing applications. Minimum deck requirements shall be in compliance with the applicable building code and be free of irregularities.
- 4. VanBoxel Building Supply Underlayment shall not be used in Roof Tile assemblies, nor shall it be hot mopped or be applied over a pre-existing roof membrane as a recover system, refer to manufacturer's literature for product compatibility.
- 5. VanBoxel Building Supply Underlayment shall not be left exposed as a temporary roof for longer than 90 days of application.
- 6. VanBoxel Building Supply Underlayment may be used with any approved roof covering Notice of Acceptance listing VanBoxel Building Supply Underlayment as a component part of an assembly in the Notice of Acceptance. If VanBoxel Building Supply Underlayment is not listed, a request may be made to the Authority Having Jurisdiction (AHJ) or Miami-Dade County Product Control Department for approval provided that appropriate documentation is provided to detail compatibility of the products, wind uplift resistance, and fire testing results.
- 7. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
