The surface shall be clean, sound and dry prior to application. All surface preparation, application methods and application rates shall be in compliance with the coating manufacturer's published application instructions and current Miami-Dade County Product Control Notice of Acceptance.

Approved Roof System Applications:

- Aluminum and Steel Metal Roofs: Prime any corroded areas with EnergyMax SBS Coating at an application rate of 1.0 gal/100 ft<sup>2</sup>. Seams shall be coated with SeamStitch SBS Caulk as needed. Allow adequate dry time between coats. A minimum of one finish coat of EnergyMax SBS Coating applied by brush, roller or spray at an application rate of 1.0 gal/100 ft<sup>2</sup>.
- Granule Surface SBS and Smooth Surface APP Modified Bitumen: Prime with a coat of SeamStitch SBS Filler at an application rate of 1.5 gal/ 100 ft<sup>2</sup>. Apply a minimum of one finish coat of EnergyMax SBS Coating applied by brush, roller or spray at a rate of 1.0 gal/ 100 ft<sup>2</sup>.
- Smooth Surface BUR: Prime with a coat of SeamStitch SBS Filler at an application rate of 1.5 gal/100 ft<sup>2</sup>. Apply a minimum of one finish coat of EnergyMax SBS Coating applied by brush, roller or spray at a rate of 1.0 gal/100 ft<sup>2</sup>.
- EPDM & TPO Single Ply: Apply a flash coat of EnergyMax SBS Coating applied by brush, roller or spray at an application rate of .75 gal/ 100 ft². Allow surface to dry thoroughly. Seams shall be coated with SeamStitch SBS Caulk as needed. Apply a minimum of one finish coat of EnergyMax SBS Coating by brush, roller or spray at an application rate of 1.0 gal/ 100 ft².
- **Hypalon Single Ply:** Seams shall be coated with SeamStitch SBS Caulk as needed. Apply a minimum of one finish coat of EnergyMax SBS Coating applied by brush, roller or spray at an application rate of 1.25 gal/ 100 ft<sup>2</sup>.
- **Spray Polyurethane Foam (SPUF):** Apply a minimum of one finish coat of EnergyMax SBS Coating applied by brush, roller or spray at an application rate of 1.5 gal/ 100 ft<sup>2</sup>.

- 1. <u>EnergyMax and EnergyGuard Elastomeric Roof Coatings are not approved as and shall not be used as a Roof or Waterproofing System as required by the Florida Building Code Chapter 15 HVHZ.</u>
- 2. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire rating of this product.
- 3. EnergyMax and EnergyGuard Elastomeric Roof Coatings shall not be applied in inclement weather conditions.
- **4.** EnergyMax and EnergyGuard Elastomeric Roof Coatings shall not be applied over asphaltic shingles, metal shingles, fiber-cement shingles, wood shingles, quarry slate, cement or clay roofing tile or wood shakes.
- 5. The products listed herein are components of roof assemblies and are approved for use with roof assemblies that list any of the products listed herein as part of their roof assemblies Notice of Acceptance.
- 6. All products listed herein shall have an unannounced follow-up quality control program from an approved listing agency. Follow up test results shall be made available to Miami Dade Product Control upon request.
- 7. Change in materials, use, or manufacture of any products listed herein shall be cause for termination of this Notice of Acceptance.
- **8.** EnergyMax and EnergyGuard Elastomeric Roof Coatings shall be applied in accordance with manufacturer's published application instructions.
- 9. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
- 10. The use of a reinforcing fabric in a maintenance coating is only to enhance the coating's ability to deliver efficient and long term and performance through the protection of the underlying roof system and in this particular use does not become a roof system itself.
- 11. EnergyMax Roof Coating System shall be used as a roof maintenance coating system in accordance with applicable Building Code. EnergyMax Roof Coating System is not approved to be used as a repair or recover system.
- 12. If SeamStitch SBS Filler or SeamStitch SBS Caulk is installed in areas exposed to weather then it must be top coated with EnergyMax SBS Coating as specified by manufacturer's published application instructions.
- 13. All approved products listed herein shall be labeled in compliance with TAS 121 and shall bear the imprint or identifiable marking of the manufacturer's name or logo, city and state of manufacturing facility, and following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.
